## AN ORDINANCE AMENDING CHAPTER 26 OF THE SOUTH ST. PAUL CITY CODE REGARDING PLANNING AND ZONING APPLICATION FEES

The City Council of the City of South St. Paul does ordain:

**SECTION 1. AMENDMENT**. South St. Paul City Code Section 26-1 is hereby amended as follows:

Sec. 26-1. - Established.

Licensing fees, permit fees and other city fees are listed in a fee schedule, which is adopted annually by city council resolution. The planning fees required by the indicated Code sections shall be shown below.
